## Supervisory Committee Call for Nomination

Applications for nominations to fill two 2024-2025 HawaiiUSA Supervisory Committee vacancies will be accepted from November 1, 2023 for consideration by the Nominations Committee. The vacancies are for three-year terms each. Basic qualifications for applicants are as follows:

- Must be a member of HawaiiUSA for at least one year (membership open prior to December 31, 2022) and in good standing.
- Must be at least 18 years of age as of December 31, 2023.

The Supervisory Committee consists of five volunteer credit union members. Primary objectives include evaluating the adequacy and effectiveness of the credit union’s internal control for safety and soundness of operations and assets, and performing or overseeing audits and verifications to comply with National Credit Union Administration (NCUA) federal requirements. Supervisory Committee members assume fiduciary responsibility, do not receive compensation, and may be required to commit many hours of their own time.

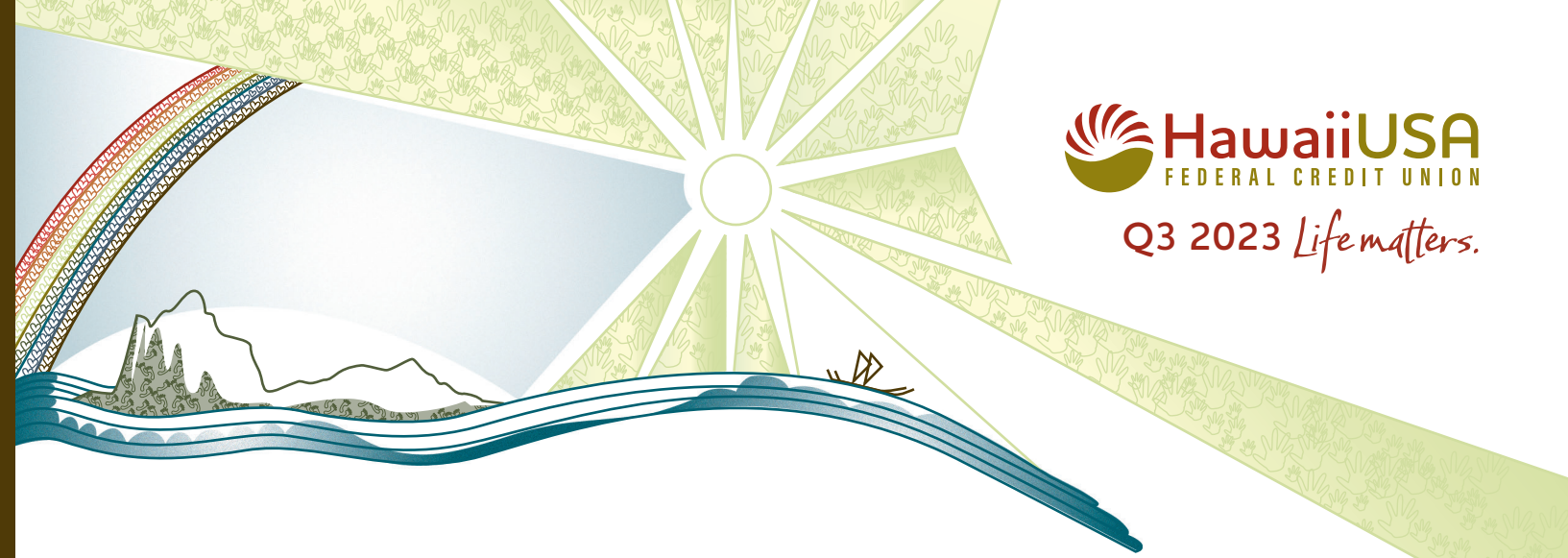
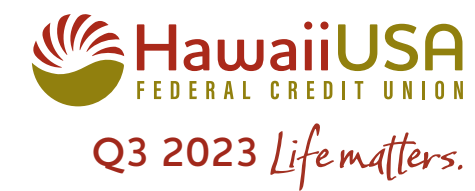

On Monday, September 18, 2023, HawaiiUSA Federal Credit Union launched the Life Matters Collective, an inaugural partnership showcasing both long-standing business partnerships and valued community partners of Hawaii’s largest credit union.
